That the bid of \$203,096.00 by METRO-YOUNG CONSTRUCTION CO., A DIVISION OF OLSON CONSTRUCTION CO., a corporation, for the CONSTRUCTION OF IMPROVEMENTS TO SOUTH CHOLLAS CREEK CHANNEL BETWEEN I-805 AND IMPERIAL AVENUE, Schedule II, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. A-00003.
