

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a contractual agreement with the SAN DIEGO HOUSING COMMISSION for the purpose of administering the 1979 CDBG Low-Income Housing Planning and Development Project, for a term commencing July 1, 1979 and ending June 30, 1980, for a total compensation of \$123,335 to be paid to Commission, under the terms and conditions set forth in said contractual agreement on file in the office of the City Clerk as Document No. R-250693.

BE IT FURTHER RESOLVED, that the transfer of \$94,975 from Fifth Year CDBG Fund 18515, Element 5930 (Social Services), and \$28,361 from Fifth Year CDBG Fund 18515, Element 5912 (Housing Rehab. - San Ysidro) for a total of \$123,335 to Fund 18515, Element 5902 (Housing Planning and Development Project) for the above said purpose, subject to HUD's approval of the Request for Release of Funds, is hereby authorized.




