
BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That the Personnel Director be and he is hereby authorized and empowered to execute, for and on behalf of said City, amended agreements with the SAN DIEGO REGIONAL EMPLOYMENT AND TRAINING CONSORTIUM (RETC) to accept an additional \$6,155,693 in CETA Title II-D funds and an additional \$3,294,356 in CETA Title VI funds to continue CETA Public Service Employment programs for the City and Subagents through September 30, 1980; and that the Personnel Director be and he is hereby empowered to extend the foregoing agreements through September 30, 1980; said agreements are on file in the office of the City Clerk as Documents Nos. RC- 250696 and RC- 250696 - 1, respectively.

BE IT FURTHER RESOLVED, that the Personnel Director be and he is hereby authorized and empowered to execute and modify as necessary, for and on behalf of said City, agreements with the following agencies for the operation of the Public Service Employment Programs pursuant to the Comprehensive Employment and Training Act (P.L. 95-524), Title II-D and Title VI, for the period December 1, 1979 through September 30, 1980, in the event the foregoing amended agreements with RETC are extended; said agreements are on file in the office of the City Clerk under documents numbers listed below:


