BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the offer of DYNECO, INC., is hereby accepted; and the City Manager is hereby authorized to execute a contract for the purchase and installation of TWO (2) EACH AQUA GUARD MODEL SK-S-T FILTER SCREENS AND ACCESSORIES for a total cost of \$285,790.00; terms net 30 days plus sales tax, plus an estimated freight charge of \$12,000.00, plus an estimated installation charge of \$2,000.00.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$316,937.40 within Sewer Revenue Fund (41506) from the Annual Allocation for main replacements (70492) to Point Loma Plant Operation (70225).
