1. That RICHARDS TREE SERVICE is hereby declared to be in default of the contract awarded by Resolution No. 250280, adopted October 1, 1979, for COMPLETE PALM TRIMMING SERVICE for approximately twenty-six thousand eight hundred eighty-seven (26,887) Palm Trees (Phoenix, Cocos and Washingtonia).
2. That the low acceptable bid of CASCIO & SON INC., is hereby accepted; and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE PALM TRIMMING SERVICE for approximately twenty-six thousand eight hundred eighty-seven (26,887) Palm Trees (Phoenix, Cocos and Washingtonia) as may be required for a period of ten (10) months beginning October 1, 1979 through July 31, 1980 per prices on file in the Purchasing Department, with an option to renew for two (2) additional one (1) year periods.
