That DROGUE PLACE, ALSACIA STREET, ALTA VIEW DRIVE, NEBRASKA AVENUE, OCARINA STREET AND PLANCHETT AVENUE, as more particularly shown on Drawing No. 14682-B on file in the office of the City Clerk as Document No. 250731 which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.
- 2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
