

RESOLUTION NO. R-250743

WHEREAS, on September 18, 1979, the City Council, in connection with its discussions and establishment of Los Penasquitos Regional Park boundaries, received two requests to have properties excluded from the boundaries of the Regional Park; and

WHEREAS, the question of whether such properties should be excluded was referred to the Public Facilities and Recreation Committee for recommendation; and

WHEREAS, the Public Facilities and Recreation Committee has recommended that both parcels be placed within the designated boundaries and that one of the two be designated for park sensitive development; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That the request by Cal Sorrento, Ltd., that certain property designated as Priority No. 3 by the Regional Park Citizens' Advisory Committee and Task Force be excluded from the Los Penasquitos Regional Park boundaries is hereby denied and said property shall be shown for planning purposes as part of the proposed Los Penasquitos Regional Park.

BE IT FURTHER RESOLVED, that the request by the owner of County Assessor's Parcel No. 341-01-03 that said property be excluded from the proposed Los Penasquitos Regional Park boundaries, which parcel is presently designated as a portion

of Priority No. 6 by the Regional Park Citizens' Advisory Committee and Task Force is hereby denied and said parcel is hereby designated for park sensitive development within said boundaries.

BE IT FURTHER RESOLVED, that it is the Council's intent that the Park Boundaries are established for planning purposes only in order to provide City staff with guidance as to the Council's wishes for potential open space acquisition or preservation and it is not intended by establishing such boundaries to hinder or preclude such property owners from developing such properties in accordance with applicable zoning and statutory requirements.
