WHEREAS, a slope easement was acquired for the improvement of MONTEZUMA ROAD in Lot 23 of Partition Map of Rancho Mission Map 330 (S.C.C. 348); and

WHEREAS, the proposed development of the property requires abandonment of the existing easement; and


WHEREAS, the easement no longer serves the purpose for which it was originally acquired; and

WHEREAS, the City has no present or prospective use for said easement and the City Manager has recommended that the City quitclaim its interests therein; NOW, THEREFORE,

That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of the City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RC-250746, quitclaiming to WILLIAM S. H. YEUNG and WUU-SHUAN YEUNG, all the City's right, title and interest in those rights of way for slope purposes, as more particularly described in said quitclaim deed.
