APPROVING MAP OF STADIUM PARK EAST UNIT NO. 1 AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE OF COMPLIANCE WITH THE AFFIRMATIVE MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by DONALD D. FARNSWORTH, a Registered Civil Engineer, entitled "STADIUM PARK EAST UNIT NO. 1 Being a subdivision of a portion of Parcel 2 of Parcel Map No. 3737, filed in the office of the County Recorder of San Diego County, May 1, 1975, and Lot 1 in Block 54 and a portion of Lot 2 in Block 50 in the 'Amended Map No. 1 of Grantville and Outlots' in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 776, filed in the office of the County Recorder of San Diego County, February 16, 1894.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public Mission Gorge Place for public purposes; and said street is hereby declared to be a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of water and drainage facilities, and the access easements in Lot 1 and Lot 2, all as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; and that those certain easements with the right of ingress and egress for the construction and maintenance of water and drainage facilities, and the access easements, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
