WHEREAS, MITCHELL PACIFIC DEVELOPMENT AND GEORGE D. KOHRT, a general partnership, have requested an exchange of drainage easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be abandoned by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the acceptance by the City Manager of that deed of MITCHELL PACIFIC DEVELOPMENT AND GEORGE D. KOHRT, a general partnership, executed in favor of the City of San Diego, bearing date of September 21, 1979, conveying to said City a drainage easement, as more particularly described in said deed, is hereby approved.

2. That the City of San Diego, by this resolution, does hereby abandon whatever right, title or interest it may have in the drainage easement, as more particularly shown on Drawing No. 14426-B on file in the office of the City Clerk as Document No. RR- 250781-1, which is by this reference incorporated herein and made a part hereof.

3. That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
