That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the STATE OF CALIFORNIA for participation in the widening of Carmel Mountain Road from I-15 to Penasquitos Drive, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-250782.

BE IT FURTHER RESOLVED, that it be and it is hereby certified that the information contained in Environmental Negative Declaration No. 75051467, on file in the office of the City Clerk, has been completed in compliance with the California Environmental Quality Act of 1970 and the State guidelines thereto, and that said Declaration has been reviewed and considered by this Council.

BE IT FURTHER RESOLVED, that the expenditure of \$90,000 from Capital Outlay Fund 30245 is hereby authorized to provide the City's share of the project's total cost of \$130,000, and the expenditure of \$90,000 from Trust Fund 63021 is hereby authorized to provide the developers share of the project's cost.
