BE IT FURTHER RESOLVED, that it be and it is hereby certified that the information contained in Environmental Negative Declaration No. 75051467, on file in the office of the City Clerk, has been completed in compliance with the California Environmental Quality Act of 1970 and the State guidelines thereto, and that said Declaration has been reviewed and considered by this Council.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$23,180.50 from Capital Outlay Fund 30245 Annual Allocation New Developments on City streets for reimbursement to Security Pacific Bank for the relocation of a sewer line be hereby authorized, solely and exclusively.
