WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Donna M. Olszewski Kris A. Barnett	Engineering and Development	\$ 95	Ms. Olszewski and Ms. Barnett are Drafting Aides. They suggested a new method of preparing patch changes for map books. This is expected to save \$972 annually in time and materials.
John E. Mills	Engineering and Development	\$ 90	Mr. Mills is a Project Officer. One year ago he earned a partial award of \$60 for his suggestion to use a simplified method of transmitting weekly Statements of Working Days. One year's experience has shown a savings of \$1,498. This is the remainder of his award.
Carl C. Copher James Froslic	General Services	\$ 75	Mr. Copher and Mr. Froslic are Equipment Mechanics in the Equipment Division. They suggested that electrical switches be installed in refuse vehicles to prevent over-packing. This is expected to save \$1,500 annually in maintenance costs. This is a partial award pending a final 12-month review.
Thomas A. Wormington George M. Harkleroad	General Services	\$ 70	Mr. Wormington and Mr. Harkleroad are Electricians in the Buildings Division. They suggested that self-energizing exit lights be used in City facilities. This is expected to save \$1,400 annually in maintenance and installation costs. This is a partial award pending a final 12-month review.
James Froslic	General Services	\$ 50	Mr. Froslic is a Service Writer in the Equipment Division. He suggested that coolant system sight glasses be installed on refuse vehicles. This is expected to save \$500 annually in maintenance costs.
