APPROVING MAP OF PLAZA MAYOR UNIT NO. 3

DEC 17 1979

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by ROBERT G. SCHOETTNER, a Licensed Land Surveyor, entitled "PLAZA MAYOR UNIT NO. 3 Being a subdivision of Lots 1 through 24, inclusive, in Block 7 and Lots 1 through 48, inclusive, in Block 8 of Tia Juana City, together with those portions of Front Street, New Orleans Avenue, the west half of the Alley adjacent to Block 7 and the Alley in Block 8, all closed to public use on October 11, 1890, by the Board of Supervisors of San Diego County, all being in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 562, filed in the office of the County Recorder of said San Diego County, August 29, 1888.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public a portion of Camino De La Plaza for public purposes, and said portion as a street is hereby declared to be a portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of water facilities, as granted and shown on said map and subject to the conditions set forth thereon.


