

RESOLUTION No. R-250855 (R-80-1021)

Adopted on DEC 17 1979

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of ROMAN CATHOLIC BISHOP OF SAN DIEGO, a California corporation, executed in favor of The City of San Diego, conveying to said City the permanent easement and right-of-way for a public street and incidents thereto, over, under, upon, along, and across the Easterly 14 feet of Lot 16, Aloha Tract, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named 19TH STREET.

That the City Clerk is hereby authorized and directed to cause said deed and a certified copy of this resolution attested by him under seal to be recorded in the office of the County Recorder.
