

RESOLUTION No. R-250858 (R- 80-1023)


Adopted on DEC 17 1979

That the acceptance by the City Manager of that street easement deed of VILLA COLINA, LTD., a limited partnership, by Horizon Development Corporation, a general partner, executed in favor of The City of San Diego, conveying to said City an easement for public street purposes over, along and across those portions of Lots 7 and 8 of Country Paradise, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named MEADE AVENUE.
