BE IT RESOLVED, by the Council of The City of San Diego,
as follows:


Said Council hereby finds that that certain map surveyed by TOM TOMISLAV PANTICH, a Registered Civil Engineer, entitled "MAYBERRY TRACT Being a subdivision of Lots 1, 2, 3, 4, 5, 6, 26, 27 and 28, of Block 116, Lot 15 and portions of Lots 14, 16, 17, 18 and 19 in Block 115 of Morena according to the Map thereof No. 809 filed in the office of the County Recorder of San Diego County January 2, 1896, together with a portion of Hartford Street, portions of Illion Street and Gesner Street and portions of the Alleys in said Blocks 115 and 116 as closed and vacated to public use and portion of Alley in said Block 116 as dedicated to public use, all in the City of San Diego, County of San Diego, State of California., " is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, a portion of Illion Street and the Alley for public purposes, and said portion of a street and the Alley are hereby declared to be a portion of a public street and public alley and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, and that

said portion of a public street and the public alley are accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
