BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the Executive Director of the Housing Commission is hereby authorized and empowered to execute an agreement with the San Ysidro Urban Council pursuant to which the Commission shall loan not to exceed \$12,500 to the Urban Council for the purpose of securing an option to purchase a privately-owned 1.66 acre parcel adjacent to the City-owned site at Coronado and Beyer Boulevard, and pursuant to which agreement the Urban Council shall be granted not to exceed \$7,500 for the purpose of securing preliminary engineering and architectural services for the development of a low-income housing project on the property at Coronado and Beyer Boulevard, under the terms and conditions set forth in that agreement on file in the office of the City Clerk as Document No. RR- 250874.

BE IT FURTHER RESOLVED, that the transfer of \$20,000 from Fund 18513 CDBG Third Year for the purposes of said agreement is hereby authorized and approved.
