That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an amendment to Task Order No. 5 of the agreement with CH₂M HILL CALIFORNIA, INC., LOWRY AND ASSOCIATES, BOYLE ENGINEERING CORPORATION, JOHN CAROLLO AND ASSOCIATES and RICK ENGINEERING COMPANY, a Joint Venture in connection with the South Bay Wastewater System and Related Facilities to amend the modification of the secondary treatment requirements by adding the anticipated public hearings conducted by the EPA and providing for additional funds to pay for unanticipated cost overruns that occurred in preparation of the application for the modification of the secondary treatment requirement of Public Law 92-500, under the terms and conditions set forth in the amendment to Task Order No. 5 on file in the office of the City Clerk as Document No. R-250877.


