WHEREAS, the successful implementation of the Marina/Columbia Residential Project requires Block Grant Funds in the estimated amount of \$12,500,000; and

WHEREAS, Block Grant Funding in the amount of \$12,500,000 is included in the approved Marina/Columbia Residential Project Budget which is set forth in that document on file in the office of the Secretary of the Redevelopment Agency as Document No. 508;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the work program and budget for the Marina/Columbia Residential Project as set forth in that document on file in the office of the City Clerk as Document No. RA 250879, be, and the same are hereby approved.

2. That the City Auditor is hereby authorized for the purpose of implementing the Marina/Columbia Residential Project to transfer the sum of \$3,680,000 from Community Development Block Grant Fund No. 18515 to the Redevelopment Agency as an advance to be repaid from tax increments or other project revenues.

3. That the Executive Director of the Agency, or his designee, is hereby authorized to expend the sum of \$3,680,000 from Community Development Block Grant Fund No. 18515 for the purpose of implementing the Marina/Columbia Residential Project.
