That the bid of ENVIRONMENTAL CARE, INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for COMPLETE LANDSCAPE MAINTENANCE OF TWO (2) CITY COMMUNITY PARKS as may be required for a period beginning December 17, 1979 through November 30, 1980 at a cost of \$7,195.00 per month for a total cost of \$82,742.30; terms 2% 20 days with an option to renew for two (2) additional one-year periods.
