BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter X, Article 1, Division 4 of the San Diego Municipal Code be, and it is hereby amended by amending Section 101.0430.1 to read as follows:

SEC. 101.0430.1 C-1 ZONE

proposes to exceed the limitations imposed by the zoning regulations pertinent to commercial development within the individual commercial zones.


