AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION JAN 4 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0432.1 REGARDING THE C ZONE (GENERAL COMMERCIAL).

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 4 of the San Diego Municipal Code be, and it is hereby amended by amending Section 101.0432.1 to read as follows:

SEC. 101.0432.1 C ZONE (GENERAL COMMERCIAL)

  - 7. Special Provision

    Any building or structure, erected under a building permit issued prior to March 1, 1971, utilized in whole or in part for residential purposes and located on commercially zoned property shall not require a variance for any

structural expansion or modification except when such expansion or modification proposes to exceed the limitations imposed by the zoning regulations pertinent to commercial development within the individual commercial zones.

## F. OFF-STREET PARKING REGULATIONS

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
