AN ORDINANCE AUTHORIZING THE EXECUTION OF LEASE AGREEMENTS WITH THE SAN DIEGO UNIFIED SCHOOL DISTRICT FOR THE PURPOSE OF LEASE, DEVELOPMENT AND MAINTENANCE OF A PORTION OF THE VALENCIA PARK AND PENN ELEMENTARY SCHOOL SITES AND A PORTION OF THE BAY TERRACES JUNIOR HIGH SCHOOL SITE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with the SAN DIEGO UNIFIED SCHOOL DISTRICT for the purpose of lease, development and maintenance of a portion of the Valencia Park Elementary School site for a term of 25 years, under the terms and conditions set forth in that Lease Agreement on file in the office of the City Clerk as Document No. 20-15162-/.

Section 2. That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with the SAN DIEGO UNIFIED SCHOOL DISTRICT for the purpose of lease, development and maintenance of portions of the Bay Terraces #13 Junior High School--Code 1969-13 and the Penn Elementary School sites for a term of 25 years, under the terms and conditions set forth in that Lease Agreement on file in the office of the City Clerk as Document No. OO-15162-2

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
