AN ORDINANCE INCORPORATING 6.4 ACRES BETWEEN
BROADWAY AND ROUTE 94, AND 29TH AND 30TH STREETS,
EXCLUSIVE OF 30TH STREET FRONTAGE, IN THE GREATER
GOLDEN HILL PRECISE PLAN AREA, IN THE CITY OF SAN
DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY
SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE,
AND REPEALING ORDINANCE NO. 12795, APPROVED APRIL 14,
1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO
INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That 6.4 acres between Broadway and Route 94, and 29th and 30th Streets, exclusive of 30th Street frontage, in the Greater Golden Hill Precise Plan Area, in the City of San Diego, California, within the boundary of the district designated "R-3A" on Zone Map Drawing No. C-654 be, and it is hereby incorporated into R-3A Zone, as such zone is described and defined by Section 101.0412 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12795, approved April 14, 1930, of the ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.

Section 2. That Ordinance No. 12795, approved April 14, 1890, of the ordinances of The City of San Diego, be, and it is hereby repeated into Far as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirlieth day from and after its passage, and no building permits from the conflicts herewith.
