AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 1,

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter VI, Article 1, Division 3, of
the San Diego Municipal Code, be and it is hereby amended to
read as follows:

SEC. 61.0339 IMPROVEMENT BONDS

Improvement bonds may be issued as provided in
Division 7, Part 5, of the California Streets and High-
ways Code (Improvement Act of 1911) commencing with
Section 6400 thereof, or as provided in Division 10 of
said Code (Improvement Bond Act of 1915) commencing
with Section 8500. Said provisions are hereby adopted
and referred to and made part of this division with the
same force and effect as if specifically set forth
herein.

Section 2. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.

Improvement bonds may be issued as provided in Division 12, Chapter 7, of the California Streets and Highways Code (Municipal Improvement Act of 1913, Sections 10600 through 10609). Said provisions are hereby adopted and referred to and made part of this division with the same force and effect as if specifically set forth herein, except that no bonds shall be issued pursuant to the Improvement Bond Act of 1915 and all references therein to said act should be considered eliminated. 7, Part 5 of the California Streets and Highways Code (Improvement Act of 1911) commencing with Section 6400 thereof, or as provided in Division 10 of said Code (Improvement Bond Act of 1915) commencing with Section 8500. Said provisions are hereby adopted and referred to and made part of this division with the same force and effect as if specifically set forth herein.
