AN ORDINANCE AMENDING ORDINANCE NO. 12700 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY AMENDING DOCUMENT NO. 766809, AS ADOPTED AND AMENDED THEREIN, BY ADDING 1.00 ASSOCIATE PLANNER AND 2.00 INTERMEDIATE CLERK POSITIONS TO THE PLANNING DEPARTMENT (065); AUTHORIZING AND DIRECTING THE CITY AUDITOR AND COMPTROLLER TO TRANSFER WITHIN THE GENERAL FUND 100 THE SUM OF \$27,939 FROM THE UNALLOCATED RESERVE (605) TO THE PLANNING DEPARTMENT (065) FOR ADDITIONAL PERSONAL AND NONPERSONAL EXPENSE.

WHEREAS, earlier this year the California Supreme Court decided the case of Horn v. County of Ventura; and

WHEREAS, that decision required local governments to expand the scope of public noticing to include areas of decision-making not previously noticed; and

WHEREAS, the most obvious effect of the Court's decision will be the necessity to give public notice of all tentative subdivison maps being considered by the Subdivision Board; and

WHEREAS, this means that notices of public hearing will have to be sent to all property owners of record within 300 feet of each proposed tentative map; and

WHEREAS, this will require significant increases in costs and demands upon staff time; and

WHEREAS, the Planning Commission was presented with all the facts and reviewed this matter on October 25, 1979; and

WHEREAS, the Planning Commission directed the Planning
Department to proceed immediately with the implementation of
the revised noticing procedures; and

WHEREAS, the Commission recommends to the City Council the approval for and authorization of three (3.0) additional staff personnel in order to adequately implement the necessary public hearing procedures; and

WHEREAS, the expense of the three (3.0) positions and associated costs being recommended will be reimbursed to the City through additional charges to the applicant; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as flllows:

Section 1. That Ordinance No. 12700 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending the fiscal allocations and personnel authorization for the Planning Department (065) to include the transfer of the sum of \$27,939 from the General Fund 100, Unallocated Reserve (605) to said Planning Department for personal services and nonpersonal services in accordance with the proposed budget allocation attached hereto as Attachment A.

Section 2. That Ordinance No. 12700 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending that portion of the Position and Salary Schedule for the Planning Department (065) to reflect and authorize the addition of one (1.0) Associate Planner to program 06530 and two (2.0) Intermediate Clerks to program 06520.

Section 3. That the City Auditor and Comptroller be and he is hereby authorized and directed to transfer within the General Fund 100 the sum of \$27,939 from the Unallocated Reserve (605) to the above-mentioned department and activities for personal services and nonpersonal services in accordance with the proposed budgetary allocation attached hereto as Attachment A.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
