AN ORDINANCE AMENDING ORDINANCE NO. 12700 (NEW SERIES), ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY AMENDING DOCUMENT NO. 766809, AS ADOPTED AND AMENDED THEREIN, BY DELETING 14.50 POSITIONS IN THE DEPARTMENTS OF THE CITY AUDITOR AND COMPTROLLER, PLANNING, FIRE, BUILDING INSPECTION AND WATER UTILITIES AND REAPPROPRIATING THE SUM OF \$399,299.00 TO NON PERSONNEL EXPENSE ACCOUNTS IN SAID DEPARTMENTS TO FINANCE CONTRACTUAL OBLIGATIONS WITH SAN DIEGO DATA PROCESSING CORPORATION, INC., FOR THE PROVISION OF DATA PROCESSING SERVICES.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Ordinance No. 12700 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Document No. 766809, as adopted and amended therein, by deleting 14.50 positions in the departments of the City Auditor and Comptroller, Planning, Fire, Building Inspection and Water Utilities and reappropriating the sum of \$399,299.00 to Non Personnel Expense Accounts in said departments to finance contractual obligations with San Diego Data Processing Corporation, Inc. for provision of data processing services, all as more fully described in Exhibit A attached hereto and made a part of this ordinance.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
