AN ORDINANCE AMENDING ORDINANCE NO. 12700 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY AMENDING DOCUMENT NO. 766809, AS ADOPTED AND AMENDED THEREIN, BY TRANSFERRING THE SUM OF \$170,000 FROM WATER REVENUE FUND (41502) UNALLOCATED RESERVE (70679) TO THE WATER OPERATING FUND (41500) WATER MAIN MAINTENANCE (70540) TO PROVIDE FUNDS FOR CONSTRUCTION OF CATHODIC PROTECTION STATIONS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 12700 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Document No. 766809, as adopted and amended therein, by transferring the sum of \$170,000 from Water Revenue Fund (41502) Unallocated Reserve (70679) to the Water Operating Fund (41500) Water Main Maintenance (70540), to provide funds for construction of cathodic protection stations.

Section 2. That the expenditure and transfer of the sum of \$170,000 from the Water Revenue Fund (41502) Unallocated Reserve (70679) to the Water Operating Fund (41500) Water Main Maintenance (70540), is hereby authorized.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
