AN ORDINANCE AMENDING ORDINANCE NO. 12666 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR FISCAL YEAR 1979-80," BY AMENDING EXHIBITS A AND B THERETO TO CREATE THE CLASSIFIED POSITION OF MICROBIOLOGIST III, AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. Ordinance No. 12666 (New Series), as amended, entitled, "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1979-80," is hereby amended to create and establish the classified position of Microbiologist III.

Section 2. As a schedule of compensation for the position created in Section 1 hereof, the following standard rate number of the Table of Pay for Standard Rates established and adopted by Ordinance No. 12666 (New Series), as amended, of the ordinances of said City, is hereby adopted:



Section 3. The position of Microbiologist III shall be inserted in Exhibit B of Ordinance No. 12666 (New Series), as amended, under the proper category.

Section 4. The Auditor and Comptroller is hereby directed to amend as necessary Exhibit A of Ordinance No. 12666 (New Series), as amended, by calculating and inserting in said Table of Pay for Standard Rates the new rates attached hereto as Exhibit 1 with the salary ranges indicated.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

AN ORDINANCE AMENDING ORDINANCE NO. 1200 (NEW SERIES) AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR FISCAL YEAR 1979-80," BY AMENDING EXHIBITS A AND B THEREIN TO CREATE THE CLASSIFIED POSITION OF MICROBIOLOGIST III, AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.
The adoption of this ordinance will amend the ordinance establishing a schedule of compensation for officers and employees of the City of San Diego for Fiscal Year 1979-80 by creating the class of Microbiologist III. The salary for said class shall range from \$1419.00 to \$1715.00 per month.
