AN ORDINANCE AMENDING ORDINANCE NO. 12666 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR FISCAL YEAR 1979-80," BY AMENDING EXHIBITS A AND B THERETO TO CREATE THE CLASSIFIED POSITION OF MICROBIOLOGIST III, AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Ordinance No. 12666 (New Series), as amended, entitled, "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1979-80," is hereby amended to create and establish the classified position of Microbiologist III.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
