AN ORDINANCE INCORPORATING LOT 16, BLOCK 96, MIDDLETOWN AND PORTIONS OF OLIVE AND HORTON STREETS CLOSED (APPROXIMATELY 6,600 SQUARE FEET), LOCATED ON THE EAST SIDE OF REYNARD WAY BETWEEN ARROYO DRIVE AND EAGLE STREET, IN THE UPTOWN COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A ZONE, AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12987 APPROVED OCTOBER 20, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BY IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lot 16, Block 96, Middletown and portions of Olive and Horton Streets Closed (approximately 6,600 square feet), located on the east side of Reynard Way between Arroyo Drive and Eagle Street, in the Uptown Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "R-2A" on Zone Map Drawing No. B-3288, be, and it is hereby incorporated into R-2A Zone, as such zone is described and defined by Section 101.0410 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12987, approved October 20, 1930, of the ordinances of the City of San Diego, be and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions

of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
