AN ORDINANCE AMENDING CHAPTER III, ARTICLE 3,
DIVISION 16, OF THE SAN DIEGO MUNICIPAL CODE
BY AMENDING SECTION 33.1625.5(c) AND (e),
RELATING TO CARDROOM REGULATIONS.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter III, Article 3, Division 16,
of the San Diego Municipal Code be and the same is hereby
amended by amending Section 33.1625.5(c) and (e) to read
as follows:

SEC. 33.1625.5 REGULATIONS

First paragraph, subsections (a) and (b) remain
the same.

(c) No establishment licensed under this article
as a cardroom shall contain more tables for the playing
of cards than the number for which the license fee has
been paid, but, in no case, shall any establishment
contain more than seven (7) tables for the playing of
cards.

Subsection (d) remains the same.

(e) Cardrooms shall be located on the ground
floor and so arranged that the playing surface of each
table is plainly visible from the sidewalk immediately
adjacent to said cardroom. As used in this section
"sidewalk" means that portion of a public highway or

public street other than the roadway, which is set apart by curbs, barriers, markings or other delineation for pedestrian travel.

Subsections (f), (g) and (h) remain the same.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
