AN ORDINANCE AMENDING CHAPTER V, ARTICLE 4, DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE BY RENUMBERING THE PROVISIONS OF SAID DIVISION IN ACCORDANCE WITH SECTION 11.05.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter V, Article 4, Division 1 of the San Diego Municipal Code entitled General Provisions be, and the same is hereby amended by renumbering said existing sections in accordance with Section 11.05 as follows:
