AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 5 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0507 RELATING TO CONDITIONAL USE PERMITS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 5 of the San Diego Municipal Code be, and it is hereby amended by amending Section 101.0507 to read as follows:

SEC. 101.0507 CONDITIONAL USE PERMIT GRANTED BY CITY COUNCIL

The City Council shall have the authority, under conditions herein provided, to permit by conditional use permit the following uses in any zone including interim zones except as otherwise provided in paragraph "A.5." of this section.

- 1. Airports, including permanent heliports and helistops.
 - 2. Amusement parks.
 - 3. Cemeteries, mausoleums and crematories.
 - 4. Fairgrounds.
 - 5. Newspaper publishing plants.
 - 6. Race tracks.
- 7. Radio or television transmission stations and broadcasting studios.

8. Camping parks, together with incidental facilities for convenience of occupants, in any commercial or industrial zone except in the SR Zone and in the agricultural zones and FW (Floodway) Zone.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
