AN ORDINANCE AMENDING ORDINANCE NO. 12700 (NEW SERIES), AS AMENDED, ENTITLED, "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY AMENDING DOCUMENT NO. 766809, AS ADOPTED AND AMENDED THEREIN, BY APPROPRIATING THE SUM OF \$6,000,000.00 OF UNAPPROPRIATED GENERAL FUND TAX REVENUE; AUTHORIZING INCREASE OF ESTIMATED REVENUE IN THE GENERAL FUND; AND AUTHORIZING THE TRANSFER OF GENERAL FUND UNAPPROPRIATED REVENUE TO A SPECIAL FUND FOR STORM DAMAGE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 12700 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Document No. 766809, as adopted and amended therein, by appropriating the sum of \$6,000,000.00 of unappropriated General Fund Tax Revenue; authorizing the increase of estimated Revenue in the General Fund and authorizing the transfer of General Fund Unappropriated Revenue to a Special Fund for storm damage.

Section 2. That the expenditure and transfer of the sum of \$6,000,000.00 from unappropriated General Fund Tax Revenue to a special fund for storm damage is hereby authorized.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
