AN ORDINANCE AMENDING ORDINANCE NO. 12700 (NEW SERIES), AS AMENDED, ENTITLED, "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY AMENDING DOCUMENT NO. 766809, AS ADOPTED AND AMENDED THEREIN, BY TRANSFERRING THE SUM OF \$250,000 FROM THE PUBLIC LIABILITY INSURANCE RESERVE FUND (81140) TO THE GENERAL FUND 100, DEPARTMENT 601, CLAIMS PROGRAM (ORGANIZATION 106) FOR THE PURPOSE OF PROVIDING FUNDS FOR PAYMENT OF CERTAIN CLAIMS FOR THE REMAINDER OF FISCAL YEAR 1979-80.

WHEREAS, the current year budget allocation for the Claims Program is \$700,000; and

WHEREAS, an increase in the number of claims filed, along with a number of large settlements and court awards, requires an estimated additional \$250,000 for payment of claims for the remainder of fiscal year 1979-80; and

WHEREAS, the Public Liability Insurance Reserve Fund
(81140) (herein called "Reserve Fund") was established for the
purpose of providing funds to supplement the Claims Program
when needed; and

WHEREAS, the Reserve Fund has sufficient funds to acommodate this request; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 12700 (New Series), as amended, entitled, "AN ORDINANCE ADOPTING THE ANNUAL BUDGET

FOR THE FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by transferring the sum of \$250,000 from the Public Liability Insurance Reserve Fund (91140) to the General Fund 100, Department 601, Claims Program (Organization 106) for the purpose of providing funds for payment of certain claims for the remainder of fiscal year 1979-80.

Section 2. That Resolution No. 251566, adopted by Council on April 8, 1980, be and the same is hereby rescinded.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of the City of San Diego.
