AN ORDINANCE INCORPORATING A PORTION OF LOT 31, ALL OF LOTS 32 THROUGH 35, AND A PORTION OF LOT 36, BLOCK 48, CITY HEIGHTS, MAP NO. 1007 (APPROXIMATELY 16,800 SQUARE FEET), LOCATED ON THE WEST SIDE OF 43RD STREET BETWEEN UNIVERSITY AVENUE AND WIGHTMAN STREET, IN THE MID-CITY COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NOS. 6173 (NEW SERIES), ADOPTED JULY 1, 1954 AND 7868 (NEW SERIES), ADOPTED MAY 15, 1958, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Lot 31, all of Lots 32 through 35, and a portion of Lot 36, Block 48, City Heights, Map No. 1007 (approximately 16,800 square feet), located on the west side of 43rd Street between University Avenue and Wightman Street, in the Mid-City Community Plan area, in the City of San Diego, California, within the boundary of the district designated "R-3A" on Zone Map Drawing No. B-3309, be, and it is hereby incorporated into R-3A Zone, as such zone is described and defined by Section 101.0412 of the San Diego Municipal Code.

Section 2. That Ordinance Nos. 6173 (New Series), adopted July 1, 1954, and 7868 (New Series), adopted May 15, 1958, of the ordinances of The City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
