AN ORDINANCE AMENDING CHAPTER II, ARTICLE 6, OF THE SAN DIEGO MUNICIPAL CODE BY REPEALING SECTION 26.32, RELATING TO THE COMMUNITY RELATIONS BOARD.

WHEREAS, the Community Relations Board (CRB) was established by Ordinance No. 11425 (New Series) pursuant to the authority of San Diego Charter Section 43(a) and incorporated in the San Diego Municipal Code as Section 26.32; and

WHEREAS, CRB was staffed by members of the City of San Diego Community Relations Department (herein called "Department"); and

WHEREAS, the City Council acted on July 18, 1978 to disestablish Department from the enumerated departments of the City; and

WHEREAS, the original thrust of CRB was to work with the support of said staff within the Model Cities Neighborhood program (herein called "program"), which no longer exists; and

WHEREAS, because of the absence of Department staff and limitations on the use of other City staff and the termination of the program, the CRB determined it could not continue to function effectively and recommended Council action to dissolve and disestablish CRB; NOW, THEREFORE,

BE IT ORDAINED, By the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 6, of the San Diego Municipal Code be and the same is hereby amended by repealing Section 26.32 as follows:

SEC. 26.32 CITY OF SAN DIEGO COMMUNITY RELATIONS BOARD

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
