AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 6, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 86.23(a), RELATING TO PARKING VEHICLES FOR SALE OR SERVICE PROHIBITED.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 6, of the San Diego Municipal Code be and the same is hereby amended by amending Section 86.23(a) to read as follows:

SEC. 86.23 PARKING VEHICLES FOR SALE OR SERVICE PROHIBITED.

- No person shall stand or park any vehicle upon any street while displaying such vehicle for sale or while selling merchandise therefrom unless authorized by other provisions of this Code. A vehicle shall not be considered to be displayed for sale when it is parked on a public street if the vehicle contains a for sale sign not greater than eight and one-half inches (8 1/2") by eleven inches (11") and the sign is placed on a side window and presents no impediment to the view of the driver when the vehicle is in operation.
 - (b) through (d) -- no amendments to these paragraphs.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
