AN ORDINANCE INCORPORATING LOTS 17 AND 18, BLOCK 203, UNIVERSITY HEIGHTS, AMENDED MAP G. A. D'HEMECOURT (APPROXIMATELY 7,000 SQUARE FEET), LOCATED ON THE EAST SIDE OF OREGON STREET BETWEEN UNIVERSITY AVENUE AND LINCOLN AVENUE, IN THE PARK NORTH EAST COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12889, APPROVED JULY 7, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 17 and 18, Block 203, University Heights, Amended Map G. A. D'Hemecourt (approximately 7,000 square feet), located on the east side of Oregon Street between University Avenue and Lincoln Avenue, in the Park North East. Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "R-3A" on Zone Map Drawing No. B-3308, be, and it is hereby incorporated into R-3A Zone, as such zone is described and defined by Section 101.0412 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12889, approved July 7, 1930, of the ordinances of The City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building

permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
