AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 6, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 86.23(d) RELATING TO PARKING VEHICLES FOR SALE OR SERVICE PROHIBITED.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 6, of the San Diego Municipal Code be and the same is hereby amended by amending Section 86.23(d) to read as follows:

SEC. 86.23 PARKING VEHICLES FOR SALE OR SERVICE PROHIBITED

- (a) through (c) -- no amendments to these paragraphs.
- (d) No person who deals in or whose business involves the sale, lease or rental of vehicles or whose business involves the transportation of persons by motor vehicles as a charter-party carrier of passengers, shall store, stand or park any vehicle upon any public street while the vehicle is held for sale, lease, charter or rental.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
