AN ORDINANCE AMENDING ORDINANCE NO. 12700 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY AMENDING DOCUMENT NO. 766809, AS ADOPTED AND AMENDED THEREIN, BY TRANSFERRING THE SUM OF \$235,500 FROM THE UNEMPLOYMENT INSURANCE RESERVE FUND (60-060) TO THE CAPITAL IMPROVEMENT PROJECT 34-036(80) FOR THE PURPOSE OF FUNDING CONSTRUCTION CONTRACTS FOR CIVIC THEATRE REHABILITATION.

WHEREAS, Capital Improvement Project 34-036(80) has \$324,000 allocated in the current fiscal year and \$235,500 programmed in the next fiscal year; and

WHEREAS, construction contracts must be awarded before July 1, 1980, to achieve a July 14, 1980 construction start date; and

WHEREAS, it is desired and necessary to transfer the remaining sum of \$235,500 from the Unemployment Insurance Reserve Fund for the purpose of funding the project fully at this time, said Reserve Fund to be reimbursed upon Council's approval of the fiscal year 1981 Capital Improvement Project 34-036(81); NOW, THEREFORE,


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 12700 (New Series), as amended, entitled "An Ordinance adopting the Annual Budget for the fiscal year 1979-80 and appropriating the necessary money

to operate the City of San Diego for said fiscal year," be and the same is hereby further amended by transferring the sum of \$235,500 from the Unemployment Insurance Reserve Fund (60-060) to the Capital Improvement Project 34-036(80) for the purpose of fully funding construction contracts for the Civic Theatre Rehabilitation Project.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
