AN ORDINANCE AMENDING CHAPTER II, ARTICLE 6,

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter II, Article 6, of the San Diego
Municipal Code be and the same is hereby amended by adding
Section 26.03 to read as follows:

SEC. 26.03 OFFICIAL RECORDS OF BOARDS AND
COMMISSIONS

Official records of the Boards and Commissions
of The City of San Diego may be maintained by the
City Department responsible for staffing each Board
and Commission unless otherwise provided by State law
or the City Charter.

Section 2. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.
