AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 6, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 86.11, RELATING TO PARKING METER ZONES AND RATES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 6 of the San Diego
Municipal Code be and the same is hereby amended by amending Section
86.11 to read as follows:

SEC. 86.11 PARKING METER ZONES AND RATES--AUTHORITY

The City Council may by ordinance establish and define parking meter zones and parking meter rates under the authority of Section 22508 of the California Vehicle Code.

The Council hereby establishes that the basic parking rate shall be five cents $(5\cancel{c})$ for each twelve (12) minutes or part thereof, ten cents $(10\cancel{c})$ for each twenty-four (24) minute interval, twenty cents $(20\cancel{c})$ for each forty-eight (48) minute interval, or twenty-five cents $(25\cancel{c})$ for each sixty (60) minute interval or part thereof.

In any parking meter zone, when any vehicle shall be parked in any space alongside of or next to which a parking meter is located in accordance with the provisions of this chapter, the operator of said vehicle shall, upon entering said parking space, immediately cause to be deposited coins in the appropriate denomination according to the time

interval desired within the maximum limit and the posted parking rates.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
