AN ORDINANCE AMENDING CHAPTER III, ARTICLE 1, DIVISION 3 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 31.0396, RELATING TO CARDROOM TABLE LICENSE TAX.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter III, Article 1, Division 3 of the San Diego Municipal Code be and the same is hereby amended by amending Section 31.0396 to read as follows:

SEC. 31.0396 LICENSE TAX--CARDROOM TABLE

There shall be collected for each cardroom table licensed hereunder the sum of Forty Dollars (\$40.00) per table per month for the first two tables, One Hundred Dollars (\$100.00) per table per month for the third and fourth tables and Two Hundred Fifty Dollars (\$250.00) per table per month for the fifth, sixth and seventh tables, payable quarterly in advance.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
