as follows:

Section 1. That Section 22.0101 of the San Diego Muni-
cipal Code be amended by amending Rule 22 to read as follows:


Rule 22. Division of City Budget and Operations

Matters to be considered by the several standing
committees shall be assigned by resolution of the
Committee on Rules, Legislation and Intergovernmental
Relations in keeping with the general areas of responsi-
bility and the workload of each committee.

force on the thirtieth day from and after its passage.
