AN ORDINANCE AMENDING SECTION 22.0101 OF THE SAN DIEGO MUNICIPAL CODE PROVIDING FOR THE PERMANENT RULES OF THE CITY COUNCIL BY AMENDING RULE 22 RELATING TO DIVISION OF CITY BUDGET AND OPERATIONS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 22.0101 of the San Diego Municipal Code be amended by amending Rule 22 to read as follows:

## Rule 22. Division of City Budget and Operations

Matters to be considered by the several standing committees shall be assigned by resolution of the Committee on Rules, Legislation and Intergovernmental Relations in keeping with the general areas of responsibility and the workload of each committee.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
