AN ORDINANCE AMENDING CHAPTER II, ARTICLE 1, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 21.04 RELATING TO HOLIDAYS.

WHEREAS, the City Council on May 13, 1980 approved

Memoranda of Understanding between the City of San Diego and
all recognized employee organizations to provide for the
addition of a floating holiday in lieu of a fixed holiday
for Columbus Day; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 1, of the San Diego Municipal Code be amended by amending Section 21.04 to read as follows:

## SEC. 21.04 HOLIDAYS

Except where otherwise specifically defined and provided in this Code, the holidays in The City of San Diego are:

- (a) January 1st;
- (b) Third Monday in February, known as
  "Washington's Birthday";
- (c) Last Monday in May, known as "Memorial
  Day";
  - (d) July 4th;
- (e) First Monday in September, known as
  "Labor Day";

- (f) November 11th, known as "Veteran's Day";
- (g) December 25th; and
- (h) Every day appointed by the President, Governor, or the City Council for a public fast, thanksgiving or holiday.
- (i) A floating holiday to be requested by the employee and approved by the appointing authority in accordance with provisions of the Personnel Manual of The City of San Diego.

If January 1st, July 4th, November 11th or

December 25th fall upon a Sunday, the Monday following
is a holiday, and if they fall on a Saturday, the

preceding Friday is a holiday.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
