AN ORDINANCE AMENDING CHAPTER VI, ARTICLE I, DIVISION 20 OF THE SAN DIEGO MUNICIPAL CODE BY REPEALING SECTION 61.2044, RELATING TO BONDS OF PARK FACILITIES DISTRICTS.

WHEREAS, the supplemental remedies of the Improvement
Bond Act of 1915 having been made ineffectual in their
application to bonds of San Diego Open Space Park Facilities
Districts created pursuant to Division 20, Article 1,
Chapter VI of the San Diego Municipal Code; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, that Section 61.2044 of said Code entitled "Supplemental Remedies" is hereby repealed.

This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
